GUIDELINES FOR ADMISSIONS UNDER RTE
(SESSION: 2025-26)

Memo No: 8/22-2025-PS (E-1)

Dated: 01-07-2025

All recognized private schools are hereby directed to take admissions seriously of students allotted through the RTE online lottery result declared on 27.06.2025, as schools are reopening from 01.07.2025.

Schools must not delay the admission process and shall complete the admission of eligible students under the EWS/DG category within the time frame specified by the department i.e **01.07.2025 to 11.07.2025**, ensuring no eligible child allotted under RTE is denied admission without valid reasons.

1. **Document Verification Process:** After declaration of lottery-based results the list of selected candidates has been published on the official website: <http://harprathmik.gov.in>.
 - Selected candidates must report to the **allotted school within 10 days**, failing which the candidature shall be cancelled.
 - The **School-Level Committee** shall verify the documents on the following grounds:
 - a) The applicant must be a **resident of Haryana** with valid residence proof.
 - b) The address must fall within the **0-3 KM neighborhood criteria**.
 - c) Valid Supporting Documents for admission category (EWS/DG category).
 - d) Admission will be provisional and confirmed only after **successful document verification**.
 - e) **Any forged/fake/incorrect information** submitted at any stage shall lead to **cancellation of admission** and **penal action** against the guardian/parent.
2. **Grounds for Rejection by the Allotted School:** If admission is rejected, the school must clearly specify the reason on the designated portal (will launch on 03.07.2025). **All schools shall ensure that all admissions, whether accepted or rejected, are reported on the designated portal.** Valid grounds for rejection include:
 - Non-submission of valid **residence proof**.
 - Non-submission of valid **age proof**.
 - Non-submission of valid **EWS/DG or CWSN** proof.
 - For EWS, income exceeding ₹1,80,000 per annum.
 - **Duplicate applications.**

- Failure to report for document verification/admission.
 - In case the rejection is based on the distance from the applicant's home to the allotted school, the **school shall submit the rejection details to the Block-Level Committee.**
 - **Other reasons** (to be specifically mentioned).
3. **RTE Admission Monitoring & Grievance Redressal Committees:** To ensure transparency and resolve grievances, the following committees will function:
- **Block-Level Monitoring Committee:** The committee will review and resolve grievances in accordance with applicable rules. If a grievance is not resolved by the Block-Level committee **within 5 days**, it will be escalated to the First appellate Committee at the District Level. Constituted by the DEEO, comprising:
 - Concerned Block-Level Officer
 - One Govt. School Principal (as nominated by DEEO)
 - **First Appellate Committee (District Level):** DEEO and Deputy DEO of the concerned district
 - **Final Authority:** If unresolved within 5 days by District Level Committee, the matter may be escalated to the **OSD/ACSSE Officer** (Controlling Private School Officer), who shall be the final appellate authority.
 - **Suo Moto Action:** In case of any dispute against a school, the concerned committee of BEO/DEEO Level may initiate inquiry on its own motion.
 - **Vacant Seat Management:** In the event of unfilled seats under 25% RTE quota, the Department shall be competent to decide the procedure for filling such vacancies.

The applicant can call at Helpdesk number **0172-5049801** on all working days from 09:00 AM to 05:00 PM. **RegistrationID** may be kept handy while contacting the Helpline.
